    - Big Jackson has continued in face-to-face instruction mode which is reported in our monthly ECOL report to the Michigan Department of Education.
    - Big Jackson had our first Michigan Continuous Improvement (MI-CIP) planning meeting facilitated by Bernard Brown and Nicole Skrabis and attended by Lisa, Jen and Lori, with Becky joining for homework assignments. Our next meeting is later in March. The board will receive a copy of our completed MI-CIP for review and approval before the end of the fiscal year.
    - Our mid-year MAPS testing is complete and our students did not show the growth that we would have expected. Leslie Smith, NC RESA Literacy Coach, has developed a plan for improvement that teachers will be implementing for the remainder of the year.
    - We are beginning to plan for summer intervention for literacy and math. Jones suggested a monetary incentive for student attendance. Tubbergen Clark will check with Jodi DeKuiper on feasibility.
