- b. ADMINISTRATOR REPORTS
  - Kindergarten Round Up will be April 26<sup>th</sup>.
  - Jackson reported that she and the staff have been working on the new Michigan Continuous Improvement Plan (MI-CIP). The focus are will be on social emotional learning (SEL) goals. Although we will continue our improvement efforts in Literacy and Math, the SEL goal is what we will enter into MI-CIP.
  - ESSER Money: Big Jackson will receive about \$180,000 in ESSER 2 and ESSER 3 dollars. We will bring quotes for geothermal repair, HVAC propane with ventilation system, new windows in the school house, etc.
  - 23B Grant for Summer programming: Big Jackson will be part of the countywide grant for an 8-week summer programming. The board and staff will brainstorm how to recruit students to show up on June 15 for the first day of summer programming.
  - TFC Bank (formally Chemical Bank) has been charging Big Jackson with banking fees
    which they will not remove, both for district and Parent Group accounts. Last year,
    bids were received from NC RESA which included Huntington Bank, 5th/3rd Bank,
    ChoiceOne Bank, and TCF Bank (formerly Chemical Bank), which all are in the City of
    Fremont. ChoiceOne Bank was the only bank which did not propose charging bank

fees on the accounts. Therefore it is recommended to move banks for Big Jackson Schools to Choice One Bank.
