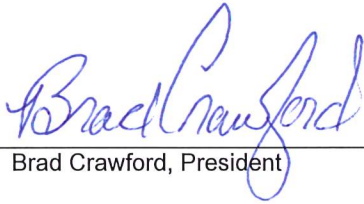
- I. **CALL TO ORDER.** Meeting was called to order by Board President Brad Crawford at 7:05pm
- II. **PLEDGE OF ALLEGIANCE** was recited.
- III. **APPROVAL OF MINUTES** – September 7, 2021 Regular Meeting Minutes. Motion by Lockerby, supported by Ulman to approve the minutes as presented. Unanimously passed.

- V. **PUBLIC PARTICIPATION**
 - a. Audit report by Mr. Kim Lindsay and Mr. William Love, Rehmann Robson: Big Jackson received an unmodified opinion, the highest opinion possible.

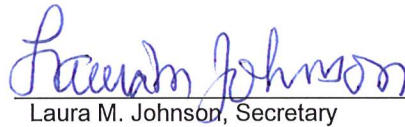
